

**A translated version of the authorisation given by
the minister of the Higher Education and scientific
research in order to establish the private higher
school of engineer of Gafsa**

ORDER

From the Minister of Higher Education and Scientific Research written and given on October 18, 2013, granting authorization for the creation of the Private Higher School of Engineers of Gafsa.

The Minister of Higher Education and Scientific Research;

-Having regard to Law n°2000-73 of 25 July 2000, relating to private higher education, together with the texts that have modified or completed it and in particular Law n°2008-59 of 4 August 2008.

-In view of the Decree n°2000-2124 of 25 September 2000, fixing the criteria and procedures for the recognition of the equivalence of diplomas delivered by private higher education institutions.

-In view of Decree n°2000-2125 of 25 September 2000, defining the conditions and regulations for granting an authorisation for the creation of a private higher education institution.

-In view of Decree n°2000-2126 of 25 September 2000, fixing the composition of the consultative commission for the granting of authorisation for the creation of private higher education establishments or its withdrawal and its functioning.

-Having regard to the Order of the Minister of Higher Education of 28 September 2000, approving the specifications governing the organisation and operation of private higher education institutions.

-Having regard to the Order of the Minister of Higher Education and Scientific Research of 15 May 2012, appointing the advisory commission for the granting of authorisation for the establishment of private higher education institutions or for its withdrawal.
